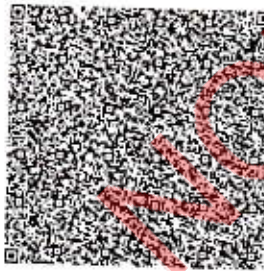

- 6.34 To support manufactures, traders and farmers for participation in international fairs, seminars and meetings with a view to create mass awareness about the importance of medicinal plants in all strata of society and explore the international market for plant based herbal products.
- 6.35 To manage training programs and develop technology upgradation / establishment / modernization of food processing industries, undertake creation of infrastructure facilities, promote quality assurance / safety concepts and organize entrepreneurs development program in connection with food processing industries.
- 6.36 To manage and administer an orphanage, old age home, nursing home, hospital, library, reading room, trust, school, college and other institution irrespective of cast creed or social status and take over absorb or amalgamate with any other society or trust or association in which the society may be interested.
- 6.37 To undertake electronics and printing technology development and utilities, transportation engineering and traffic management, handloom and textile engineering development, small-scale industry development, promotion of Khadi, handicraft and cottage industry and manage all activities supported by K.V.I.C. and employment creation.
- 6.37 To undertake research or manage short term / long term projects for harnessing Hydro, Solar or wind energies, water harnessing for irrigation and consumption and rain water harvesting for community/ village/ block development.
- 6.38 To run, manage, conduct, sponsor, coordinate, control and organize programs/ research specially related to the enlistment of disabled, their education and rehabilitation with a holistic and progressive approach under the various schemes of concerned authorities/movement.
- 6.39 To undertake sponsor or co-ordinate the training of personnel such as Doctors, Engineers, Prosthetics technicians and engineers, physiotherapists, occupational therapists, Multipurpose Rehabilitation Therapists and such other personnel for the rehabilitation of the physically handicapped / mentally handicapped / orthopedically handicapped.

- 6) **Board of Trustees:** The trust shall be vested in a Board of trustees [hereinafter called the Board] which shall consist of not less than three and not more than seven trustees. - 7.1 The Board of Trustees shall have one Chairman/Chairperson. The First Chairman/Chairperson of the Board of Trustees shall be elected by the board of Trustees amongst themselves by special majority and the chairman can be removed anytime from his office by special majority of the Board of Trustees. Normally the term of the Chairman/Chairperson will be 05 years from the date of appointment. The first Chairman of the Board will be **Amrita Choudhary**. The Chairman/Chairperson of the Trust shall be the Managing Trustee. The Managing Trustee shall be the Chairman and shall preside over the meetings. He will be the Chief Executive Officer of the Board and shall have the power to do all acts, deeds and things to carry out the aims and object of the Trust. The Terms of all other Trustees shall be of five years.
- 7.2 The first trustees constituting the Board shall have the power to increase the strength of the Board by appointing thereto one or more person on the recommendation of Chairman/Chairperson whether on the same occasion or on different occasions, as trustee or trustees, but the total number of persons constituting the Board shall at no time exceed seven.
- 7.3 In the event of vacancy in the office of the Chairman/ Chairperson, the Board shall elect a Chairman/Chairperson amongst themselves.
- 7.4 If any of the Trustee shall die, or desire to retire, refuse or become incapacitated to act as a Trustee or take the benefit of insolvency Law, then and in every such case, there shall be a vacancy in the Board.
- 7.5 A Trustee may be removed from his office in the following grounds
- (i) If the Trustee become unfit or personally incapable to act in the Trust;
 - (ii) If found guilty of (a) misconduct or abuse of office, (b) acting dishonestly or fraudulently, (c) misappropriation of trust funds, (d) moral turpitude, (e) application of trust property to private purposes etc.
- A Trustee may be removed by a resolution adopted by two third majority of the members of the Board present and voting at a meeting specially called for the purpose. The Trustee affected shall be given reasonable opportunity to show cause against the proposed action.
- 7.6 Vacancies in the Board may be filled by the remaining Trustees at a meeting called for the purpose. Casual vacancies in the Board may be filled in the manner aforesaid for the unexpired part of the term in the manner aforesaid for the unexpired part of the term of the Trustee causing vacancy. A retiring trustee shall be eligible for re-election on the recommendation of Chairman/Chairperson.
- 7.7 The quorum for a meeting of the Board shall be 1/3rd of the existing members. If the meeting have not a quorum within one hour of the fixed time, the meeting shall be adjourned to the same day and time

at the same place for the next week. Adjourned meeting shall not require having a quorum.

- 7.8 Vacancies in the Board shall not invalidate any of the proceedings of the Board.
- 7.9 The Board may meet as often as necessary but not less than twice in a calendar year and their proceeding shall be recorded regularly in minute's book to retain for purpose. In any resolution to be passed touching the administration of the Trust, the opinion of the majority shall prevail. It shall be competent however for the Trustee to decide matters by circulation. In case there being equality of votes, the Chairman of the meeting has casting votes for the purpose of deciding the issue.
- 7.10 Decisions at the meeting of the Board shall be taken by the majority of the trustees present by unanimous decision or voting. In the case of equality of votes, the Chairman of the Board shall have a second or casting votes.
- 7.11 The Trustee may frame rule and regulation as the duties and responsibilities of each Trustee, to appoint sub committees with the administration of the Trust and its management.
- 7.12 The managing Trustee of his nominee or any other Trustee so authorized by the Board of Trustees shall have the custody of all the documents, deeds, titles relating to the Trust properties and investment and the book of account and other records relating to the Trust and shall be responsible to the preservation of the same.
- 7.13 Notice shall be served personally or sent by post to the Board of Trustees seven days prior for all types of meetings.

7) Power and Functions of the Board of Trustees:-

- 8.1 To accept any donation, contribution, grant in cash or kind and avail loan or subscription from any person(s), body of persons or Trust, Government, Semi-Government department or agency, national or international donor, with or without conditions.
- 8.2 To apply the whole or any part of the income of the Trust or the Trust-Fund or accumulations thereto, to anyone or more of the objects of the Trust, as the Trustees may, in their discretion, deem fit from time to time.
- 8.3 To convert and deal with the Trust property and/or any investments for the time being.
- 8.4 To invest the Trust-Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments or in deposits with or loans to any company, Bank, Firm or any other person, and to alter, vary or transpose such investments from time to time at the discretion of the Trustees.
- 8.5 To borrow or raise or secure payments of money and also to lend money wither with or without security.
- 8.6 To sell, dispose of, alienate or otherwise deal with any property comprising the Trust-Fund.

- 8.7 To let-out, demise any immovable property compromised in the Trust-Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- 8.8 To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceeding regarding the Trust-Deed.
- 8.9 To appoint or make provision for the appointment of any person for the purpose of the administration of the Trust in such manner and subject to such rules and regulations as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustee to hold any fund or investment. Subject to the provisions of this deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- 8.10 To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- 8.11 To start, abolish, discontinue and restart any charity or and to impose any condition to any subscription or donation made by them.
- 8.12 To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for such purpose without being responsible for any loss occasioned thereby.
- 8.13 To settle all accounts and to compromise, compound, abandon or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- 8.14 To apply to the Government, Public bodies, Urban, Local, Municipal, District and other bodies, corporation, companies or persons for and to accept grant of money and of aid, donations, Gifts, Subscriptions and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government departments, public and other bodies work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- 8.15 To establish, regulate or discontinue branches, centre or project offices within India or appointing representatives or agents or advisory committees.
- 8.16 To subscribe to become a member of or otherwise cooperate with any other Trust or its branch whether incorporated or not whose objects are either wholly or in part similar to those of the Trust or which could promote the interest of the Trust.
- 8.17 The Trustees shall, from and out of the income realized from the properties, assets and funds of the Trust and from other such endowments and from the Government grants and from any other sources which they may get expend such sum or sums of money as they may deem proper towards the maintenance of the properties of the Trust, pay all rates and taxes, pay such sums towards the

repayments of any borrowing by the Trustees and meet all expenses which the Trustees may within their discretion think necessary for the proper and efficient management of the Trust and in particular pay the salaries and allowances of all staff and servants, purchase of books, equipments and furniture's pay management contribution for the provident fund of the staff gratuity, pension etc. awards; prizes or scholarships to students and incur any other item of expenditure, relating to the institutions, if any, under the management of the Trust not hereinbefore specially mentioned, it being understood that the above enumeration gives not priority to any particular item of expense nor is the same exhaustive.

- 8.18 No part of the Trust property or its income or any accretion thereto shall be applied for any purpose which is not a charitable purpose in law and all provisions hereto shall be controlled accordingly.
- 8.19 The Board of trustees have management of the affairs of the Trust and the overall supervision and superintendence of the Trust and all institution run by the Trust and all matters incidental thereto.
- 8.20 No part of the Trust property or its income or any accretion thereto shall be applied for any purpose which is not a charitable purpose in law, and all provisions hereof shall be controlled accordingly.
- 8.21 To under taking establish, run, sell, mortgage, purchase any property for the trust with concert of all trustees.

8) Accounts and Audit:

- 9.1 The account or accounts of the Trust shall be opened in the name of the Trust and/or branches, project officers centre or institutions run or conducted by the Trust with a Nationalized or Scheduled Bank or other Bank approved or permitted by the Reserve Bank of India or in Post Office and it shall be operated by one or more of the Trustees or such person authorized by Board of Trustees time to time.
- 9.2 The accounts of the Trust shall be audited every year by a Chartered Account or a firm of Chartered Accountant that will be appointed by the Board of Trustees with the consultation of the Chairman/Chairperson.
- 9.3 The audited accounts of the Trust shall be adopted at the meeting of the Board of trustees called for the purpose and remuneration of chartered Accountant or Firm of the Chartered Accountants shall be fixed by the Board of Trustees.

9) Power to amalgamate:

The Board of Trustees may allow and permit any other Trust, Institution of Charity, in any local area or areas whose objects are either wholly or in part similar to those of these presents to the intent and effect that such other Trust, Institution or charity shall be deemed to be a part and parcel of the Trust created by these Presents provided that no conditions are accepted which involve a change in the name of this Trust or inconsistent with or repugnant to the objects of the Trust.

The accounting year of the Trust shall be the financial year ending on 31st March every year.

14) Amendments:

This Trust, Trust-Fund and provisions relating to the appointment of the first Chairman/Chairperson of the Board are irrevocable. subject as aforesaid the terms of the deed may be amended, altered or modified by a majority of 2/3rd members of the Board present and voting in a meeting called for the purpose.

Provided, however, that no amendment contrary to the objects of the Trust hereinbefore set forth shall be valid and effective.

15) Interpretation of the terms of this deed of Trust:

That in case of any disputes as regarding interpretation of any terms of this DEED OF TRUST among the Trustee or between any Trustees and the Managing Trustee it shall be solved as per the provision of the INDIAN TRUST ACT- 1882.

16) Advisory Body:

The Trustee may maintain a set of advisors for the purpose of utilizing their services in furtherance of the objects of the Trust.
